**SELECTION OF PARTNERSHIPS TO FINANCE PROJECTS UNDER THE MPF 24-30**  
**STRATEGIC GOVERNANCE PLAN OF THE MILITARY PROVIDENT FUND**

The Military Provident Fund (MPF), the social mutual insurance fund for gendarmes and military personnel in Côte d'Ivoire, was created by decree N° 85-950 dated September 12, 1985. Governed by the 1898 law on associations, since June 2009, the MPF has been subject to regulation N° 07/2009/CM/UEMOA on the regulation of social mutual insurance fund within the UEMOA. Its articles of association and internal regulations were adopted by the Extraordinary General Meeting in June 2013. The MPF has adopted a Strategic Governance Plan MPF 2024-2030 (SGP 24-30) to ensure the long-term future of the Mutual by anticipating economic, regulatory and social developments. The implementation of this Strategic Governance Plan (SGP) 24-30 is based on several projects, including non-profit projects (social and administrative) and profit-making projects.

The MPF's intention is to complete all these projects for the benefit of the military and gendarmes of Côte d'Ivoire.

**The non-cumulative conditions required are as follows:**

- Being a financial builder ;
- Be able to manage a design-build project;
- Be a financial backer or capable of supporting the MPF financially;
- A proven track record in delivering large-scale projects.

**Conditions for the award of tenders :**

The Military Provident Fund's Contracts and Agreements Committee will award the tender to the legal entity or natural person submitting the best technical and financial tender.

**Project financing conditions :**

- **Non-profit projects:** The projects to be carried out are intended to improve health care for military personnel, gendarmes and any other person. The contractor will be able to benefit from a partnership to support the MPF in carrying out all the work covered by its contract.
- **Profit-making projects:** The projects to be carried out are intended to be marketed for the benefit of military personnel, gendarmes and the general public. The contract holder will be responsible for carrying out all the work covered by the contract using its/his/her own funds.

**The method of payment for the work :**

The contractor will submit payment proposals to the Military Provident Fund.

**Duration of the project :**

The contractor will submit to the Military Provident Fund an execution schedule for all the projects to be carried out, in accordance with the implementation of the MPF 24-30.

Visits to project sites can be arranged after the selection phase.

Legal entities or individuals wishing to participate in this Notice of Expression of Interest should send a letter to the General Management of the Military Provident Fund, located in Plateau, Ministry of Defense, no later than April 30, 2025 or by electronic means, quoting the registration number of this Notice and the phrase "**SELECTION OF PARTNERSHIPS FOR THE FINANCING OF PROJECTS OF THE STRATEGIC GOVERNANCE PLAN MPF 24-30 OF THE MILITARY PROVIDENT FUND - REPUBLIC OF COTE D'IVOIRE**".
